Taking photographs and recording film images of children and young people

Brownsover Community School has a responsibility to ensure the welfare and safety of children and young people.

Within school we use photographs and film for a number of reasons. The main purposes are for organisation and to celebrate the success of pupils and record learning and achievement. During the course of the school year, we may sometimes wish to take photographs or video recordings of children within school or on school trips, either for our own records, for use on coat pegs and display boards, and as part of our learning curriculum or for inclusion in our promotional material such as the school prospectus and our website or social media sites. The school may also invite in an external photographer to the school each year to take official school photographs. Additionally your child's image may be used outside of the school setting by local or national media or the local authority - common instances may involve promotion of the school to the local community or in competitions and these Images may appear in publications or channels used by the local authority or the media e.g. print, internet.

To comply with the General Data Protection Regulation, we need to ask your consent before the school record any images of your child. Your child's identity will not be disclosed without your consent and only if the photograph is used to celebrate individual success. In view of this, we request that this consent form is completed as soon as your child starts attending school here.
